	a. All individual MS Plates should be free from excessive rust, corrosion, welding	55000 KG
	seam and surface irregularities/pitted.	33000 KG
	b. All individual bare MS Plates Surface should be reasonably smooth to facilitate handling and processing.	
	c. Plus/Minus 10 (ten) percent tolerance in length and breadth is acceptable.	
	Negative allowance is not acceptable in thickness of the material.	
	d. Weight will be counted as per theoretical weight basis. During theoretical weight	
	measurement, fraction of thickness is not countable.	
	e. Plates should be securely packaged to prevent damage during transportation.
