

Material For Slipway Operating And Loading Carriage

- b. Canadian Intercontinental Impex corp.

উপস্থিত প্রতিনিধিগণের সহিত নিম্নোক্ত বিষয়সমূহের আলোকপাত করা হয়েছেঃ

1. Query from Rigel shipping: As per the tender schedule, the MTC for all six items is required to be endorsed by the classification society. However, since these items are not class-approved products, obtaining class endorsement becomes challenging. Therefore, we request a relaxation of the requirement for class approval on the MTC

Ksy's Answer: As per clause no-13, terms & conditions of mild steel material: MTC must be approved by marine classification society (BV/LR/DNV/ABS) considering the application of the material this must be followed.

2. Query from Rigel shipping: The tender schedule indicates that the products will be purchased under an LC arrangement, with 80% of the LC amount released upon arrival of the goods at the port and the remaining 20% upon acceptance at the warehouse. However, since the quotation has been requested on a CFR Chittagong basis, the supplier does not agree to the 80/20 payment terms. Instead, they request payment either through an LC at sight or 100% payment upon receipt of goods at the port.

Ksy's Answer: As per follow tender schedule clause no-15, i(a).

3. Query from Rigel shipping: The supplier in China is requesting a minimum of 20% advance payment, with the remaining 80% payable via LC. If we include this 20% advance in our quotation along with the agency fee and local transportation cost from the port to the KSY warehouse in Bangladesh, please clarify whether this would be subject to any applicable taxes.

Ksy's Answer:

- a. 23% VAT and TAX will be imposed on Local agent/ Indenting Agent commission.
- b. 20% VAT TAX to be imposed on local transport from Chittagong to Khulna Shipyard limited

4. Query from Canadian Intercontinental impex corp:

Ksy's Answer: Any Grade that complies mechanical, chemical, weather resistance and other properties will be considered as equivalent grade. If you have any suggestion, you can check the grade by asking.

5. Query from Canadian Intercontinental impex corp: Ksy required the shop to be primed before shipment, so many different processes were involved. Do you have any specific requirements or industry-standard processes that are acceptable?-For example, Spray paint for anti-corrosion coating?

Ksy's Answer: The Purpose of the Primer Coating is Corrosion Resistance.

6. Query from Canadian Intercontinental impex corp: Page#4.Terms and conditions j: "The intended mill should be class approved, and the related certificate of the steel mill is to be submitted with the tender submission". This Class is approved for marine class (e.g.,BV) or steel product classification (e.g., steel class AAA); it would be appreciated if this could be clarified.

Ksy's Answer: As the materials are marine class (BV/LR/DNV/ABS) approved, hence the MTC also should be marine class (BV/LR/DND/ABS) approved.

7. Golden Maritime Technology: Ref to tender important point ser no. 6(i): CFR basic. The inform states that the principal will be a foreign company to submit the PG. A foreign company can send PG in the form of bank guarantee only. So the correction is to be made as follows:

The successful tenderer will be required to furnish performance guarantee to the extent 10% of the total value either in the form of pay order or in the form of a bank guarantee issued by any scheduled bank of Bangladesh for the satisfactory execution of the order. The foreign principal to send the PG through their bank to our schedule bank

Ksy's Answer: Bank Guarantee Accepted.

8. Golden Maritime Technology: The same statement of CFR Basis is applicable for this clause too. The supplier shall furnish to buyer a bank guarantee for warranty (for the contracted item) from a schedule bank of Bangladesh after satisfactory handing over of the material for an amount equivalent to 5% of the contract price, which shall remain valid until expiry date of the warranty period.

Ksy's Answer: Bank Guarantee Accepted.
