1. Khulna Shipyard Limited (KSY) will procure “Rubber Chemical Items” as per attached specification (01 Page) with following terms & conditions:
2. Please send your offer CFR at Chattogram Sea Port basis within **07/12/2025 (11:30 Hours)** by e-mail or closed envelop.
  - a) Payment: Payment will be made through Letter of Credit where LC Commission (0.3% of Contract value per quarter), insurance (0.3% of Contract value) with related others cost will be borne by supplier at LC opening.
    - i. 80% of the total contract value will be paid against shipping documents and
    - ii. Rest 20% will be paid after receiving the material at KSY and satisfactory acceptance.
  - b) Shipment: 45 days from the opening date of LC.
  - c) FOB value & Ocean freight should be shown separately.
  - d) Delivery: 60 days from the Purchase Order.
3. Three percent (3%) Bid Bond/ Earnest Money (in the form of a pay order, returnable after the submission of the Performance Guarantee, PG) equivalent to the total quoted value must be submitted with the offer. This amount is subject to forfeiture if the bidder withdraws or modifies their Tender for any reason, violates the terms after the Tender opening and before the expiration of its validity, or fails to provide the required performance bond within the stipulated time after receiving the letter of intent.
4. Five percent (5%) of the total value will be submitted as a Performance Guarantee (PG) in the form of a pay order before the Purchase Order. This guarantee will be released after a satisfactory inspection of quantity, quality and weight by KSY in the presence of the supplier’s representative at the shipyard premises. The buyer reserves the right to forfeit the performance guarantee if the supplier fails to fulfill the terms and conditions of this contract, whether partially or wholly, and may take any other appropriate action against the supplier.
5. Offer Validity: 60 Days from Tender Opening Date.
