


- 4. Payment will be made through L/C. 80% of the total contract value will be paid against shipping documents and rest 20% will be paid after satisfactory reception of the consignment at KSY.
- 5. Shipment: 60 days from the opening date of L/C.
- 6. **1%** (one) Bid Bond/Earnest Money with validity 60 days of the total quoted CFR value must be submitted with the offer. Bid Bond may be Pay Order / Bank Guarantee in favour of Khulna Shipyard Limited, Bangladesh Navy, Khulna.
- 7. 10% Performance Guarantee (PG) with 180 days validity is to be submitted before issuance of PO.

8. Offer Validity: 90 Days from Tender Opening Date.

TENDER SPECIFICATION FOR WATER JET BLASTING MACHINE

- 1. **Name of the Equipment.** Water Jet Blasting Machine.
- 2. **Purpose**. Water Jet Blasting Machine is required for environment friendly high quality surface cleaning (removal of paint, rust, mill scale etc.) for repaint and surface preparation (HB 2.5 comparable to Sa 2.5 or better standard) for new built aluminum/ mild steel ship hull in open spaces and workshop of Khulna shipyard premises.
- 3. **Quantity**. 01 (One) complete set.
- 4. **Manufacturer**. Name and full address to be mentioned.
- 5. **Year of Manufacture**. 2021 or later.
- 6. **Country of Origin.** To be mentioned.
- 7. **Manufacturing Country.** To be mentioned.
- 8. <u>Certificate/ Document of Authentication</u>. The local supplier must provide following original certificate(s)/ document(s) with the offer/ quotation of items as regard to the genuinity of source and item(s) in order to establish chain of links from the original source to supply items:
 - a. One certificate/ document by the manufacturer in favor of the supplier (in case of manufacturer as direct source).
 - b. Two certificates/ documents, one by the manufacturer to authorized agent and other by the authorized agent to supplier (in case of authorized agent as immediate source).
- 9. **Standard**. The Water Jet Blasting Machine is to be designed and constructed fulfilling the requirement of International standards. The Standard to which Water Jet Blasting Machine complies with is to be specified. Standard is to be mentioned.

- ii. Hand control valve and other important safety devices compatible with the system to be supplied. (Details need to be mentioned)
- 13. **Standard Accessories**. All necessary fittings and standard accessories which are required for standard operation of high pressure water jet blasting machine, but not mentioned in this specification are to be provided with the set at the time of delivery. The list includes, but not limited to the mentioned fittings/attachment as per paragraph 12(d)(Price included in the total price)
- 14. **Safety Device.** All standard safety devices must be included. List of safety devices must be mentioned with the offer (Price included in the total price)
- 15. **Spare parts.** A list of spare parts for 01 (One) year service with item wise price are to be mentioned considering the water supply quality and environment of KSY as per paragraph 10 & 12(a)(6) (Price is not included in the total price)
- 16. <u>Tools.</u> 01 (one) set of standard tools for maintenance of high pressure water jet blasting machine is to be provided. Quantity and size of the essential tools are to be mentioned in details in the quotation (Price included in the total price)

17. Documents.

- 02 (Two) sets of following documents in English language are to be supplied with the equipment (one set to be supplied with the offer):
 - i. Operation/Service& Maintenance Manual
 - ii. Parts Catalogue
 - iii. Technical catalogue
 - iv. Performance/ standard test certificates
- 18. <u>Test, Trial, Commissioning and Acceptance</u>. Installation & test and trial will be carried out by the supplier at KSY premises. All expenses will be borne by the supplier. After satisfactory test & trial, acceptance certificate will be signed jointly by the representative of supplier and the representative of buyer.
- 19. <u>Training</u>. The supplier must provide necessary operation and maintenance training (Mechanical & Electrical) in Bangladesh to 08 persons(maintainer and operator) for 01 (One) week with the satisfaction of the buyer. The cost of the training must be borne by the supplier.
- 20. **Warranty**. Warranty for trouble free operation is to be issued by the manufacturer for a period at least 01 (One) year from the date of acceptance by the buyer. During the warranty period, if the high pressure water blasting machine remains non-operational for any trouble, the warranty will be extended for the same period. The warranty covers all parts, Accessories, tools of the high pressure water blasting machine and labor (including OEM or authorized service engineer's cost) throughout the warranty period.
- 21. **Guarantee.** The manufacturer shall guarantee to supply necessary genuine (OEM) spare parts and emergency repair service for at least 10 (Ten) years with reasonable price.
- 22. **Shipment**. The following information is to be provided:
 - a. The supplier will arrange shipment at KSY.
 - b. All items will be delivered in sea-worthy/ air worthy packing to ensure safe transportation by sea/air.
 - c. All packages are to have packing notes showing their contents in details and all packages shall be marked with the name and address of the consignee and gross weight.
- 23. **<u>Delivery.</u>** Items are to be delivered within 03 (three) months from the date of signing the contract or purchase order.
- 24. **Validity of Offer**. The offer will remain valid for 03 (three) months from the date of opening of tender.
- 25. <u>Terms of Payment</u>. L/C for full purchase amount will be opened in favor of the principal supplier under the following payment terms:
 - a.80% of total CFR value will be paid on delivery of the items described under the scope of supply and on production of necessary shipping documents.
 - b. Remaining 20% of CFR value will be paid on producing 'Acceptance Certificate' after satisfactory test and trial jointly carried out by the buyer's and supplier's representatives.
- 26. **Compliance Statement**. One set of Compliance Statement is to be submitted along with the offer by the bidder.
