#### 3. <u>Terms and Conditions:</u>

- a. Bidder should offer Lot-1 and Lot-2 together or Lot-1 or Lot-2 separately as mentioned in the scope of supply.
- b. Partial/ incomplete offer of Lot-1 or Lot-2 is not acceptable and will be treated as non-compliant.
- c. Article wise compliance sheet to be filled by the bidder.
- d. Among the technically responsive bidder/ bidders, KSY will consider lot wise lowest bidder for evaluation.
- e. The manufacturer details such as brochure or catalogue in English language is to be submitted with the offer.
- f. Pre-Shipment Inspection (PSI) of Lot-1 and Lot-2 will be conducted by KSY or KSY nominated 3<sup>rd</sup> party. In case of PSI, international air fare, food, accommodation of KSY 2 (two) personnel will be borne by the Seller for 3 days excluding journey period. In case of nominated 3<sup>rd</sup> party inspection, the cost shall be borne by the seller.
- g. Based on satisfactory PSI or 3<sup>rd</sup> party inspection report, seller will ship the goods.
- h. Manufacturer authorization letter on behalf of supplier (other than manufacturer is the supplier) will have to be submitted at the time of offer.
- i. 5% Performance Guarantee (PG) of the total contract price (TCP) will have to be submitted after issuance of NoA and before signing the contract. Validity of the PG should be upto delivery of the goods and final acceptance by the buyer. Failure to furnish PG will be considered as non-responsive.
- j. KSY will open 100% irrevocable letter of credit from any schedule of Bangladesh in favor of the supplier. The payment will be released after producing the following documents in the buyer's bank:
  - (1) Non-negotiable Bill of Lading Marked freight "prepaid".
  - (2) Invoice duly signed in ink indicating unit and total price of individual item.

(3) Certificate of origin.

- (4) Pre-shipment inspection report.
- (5) Manufacturer's certificate.
- (6) Undertaking certificate.
- (7) Copy of intimation given to Insurance Company for covering insurance. Insurance will be done by KSY.
