INVITATION FOR EXPRESSION OF INTEREST (EOI)

Reference:

A. Invitation for Tender Number 18.14.0158.427.07.565.24-621. (Tender/Proposal ID: 1037477)

1. Khulna Shipyard Ltd (KSY) invites expression of interest (EOI) from reputed Prime Contractor or Subcontractor or Management Contractor in Dredging works to work in Joint Venture (JV) for Maintenance Dredging at Section-2 of Outer Bar in Pussur Channel of Mongla Port for the procuring entity as per Reference A.

Brief description of the works is as follows:

- a. **Brief Description of the Works:** Maintenance Dredging at Section-2 of Outer Bar in Pussur Channel of Mongla Port. The dredging is to be carried out with cutter suction dredger. Approximate dredging quantity is 5,59,078 cu.m.
- b. **Procuring Entity.** Mongla Port Authority
- c. **Commencement Date of Works** 08 Jan 2025.
- d. **The Intended Completion Date** for the whole of the works shall be 31 March 2025.

2. **Qualification of Bidder.** Interested Suppliers/ Contractors should provide information indicating that they have the required qualifications and relevant experience to perform the task. The short-listing criteria for eligibility are as follows:

- a. The minimum number of years of general experience of the Contractors in the construction works as Prime Contractor or Subcontractor or Management Contractor shall be 05 years.
- b. The minimum specific experience as a Prime Contractor or Subcontractor or Management Contractor in Dredging works of at least 01 contract(s) of similar nature, complexity and methods/ construction technology successfully completed within the last 05 years, each with a value of at least **Tk. 15,00,00,000.00 (Fifteen Crore Taka)**.
- c. The minimum tender capacity shall be: **20,00,00,000.00 (Twenty Crore Taka)**
- d. The required average annual construction turnover shall be greater than **Tk 110,00,00,000.00 (One Hundred Ten Crore Taka)** over the best three (3) years in the last five (5) years.
- e. The minimum amount of liquid assets or working capital or credit facilities of the Contractors shall be **Tk 20,00,00,000.00 (Twenty Crore Taka)**
- f. Contractors shall have the minimum level of personnel capacity to qualify for the performance of the works under the contract consisting of a Construction Project Manager, Engineers, and other key staff with qualifications and experience as specified in the TDS;

- g. The Contractors must not have any litigation claim from any organization.
- h. Contractors shall own suitable equipment and other physical facilities or have proven access through contractual arrangement to hire or lease such equipment or facilities for the desired period, where necessary or have assured access through lease, hire, or other such method, of the essential equipment, in full working order.

- i. The Contractors should have Valid Trade License.
- j. The Contractors should have VAT/ Business Registration Certificate (as applicable).
- k. The Contractors should have Updated TIN/ equivalent certificate and Tax Payment Certificate (as applicable).
- l. The Contractors must have Bank Solvency Certificate.

Necessary supporting documents for mentioned eligibility criteria must be provided with the EOI.

3. **Payment Terms.** Payment shall be made after receiving from the Procuring Entity as per actual work completion.

4. **Scope of Supply of JV Partner.**

- a. JV Partner has to complete all the dredging and other works as per guideline of ref tender.
- b. JV Partner will have the sole responsibility of conducting quality work according to terms and conditions of contract at ref A.
- c. JV Partner has to arrange all the materials required for this work.
- d. JV Partner has to submit Tender Security during tender stage & Performance security after receiving NoA on behalf of KSY to procuring entity.
- e. Handling the government officials and labour unions shall be sole responsibility of the contractor. KSY will not be responsible for the same.
- f. It is the sole responsibility of the contractor for the safe custody of the materials. KSY will not be responsible for any loss, damage or theft of materials.
- g. The Suppliers/ Contractors shall be responsible for any damage caused to the Government property.
- h. KSY will not have any type of financial involvement throughout the PROJECT except tender security.

- i. Responsible for any other requirement to fulfill the contractual obligations;
- j. Supplier will issue a cross cheque during submission of the tender in favour of KSY equal amount of tender security submitted by KSY to MPA. The validity of the cross cheque will be not less than 06 months.

5. **KSY Scope of Supply.**

- a. KSY will bear the tender security but tender security issuing related all costs will be borned by the supplier.
- b. Maintain liaison with Procuring Entity;
- c. Provide shipyard facilities and services at mutual agreement on cost to cost basis;

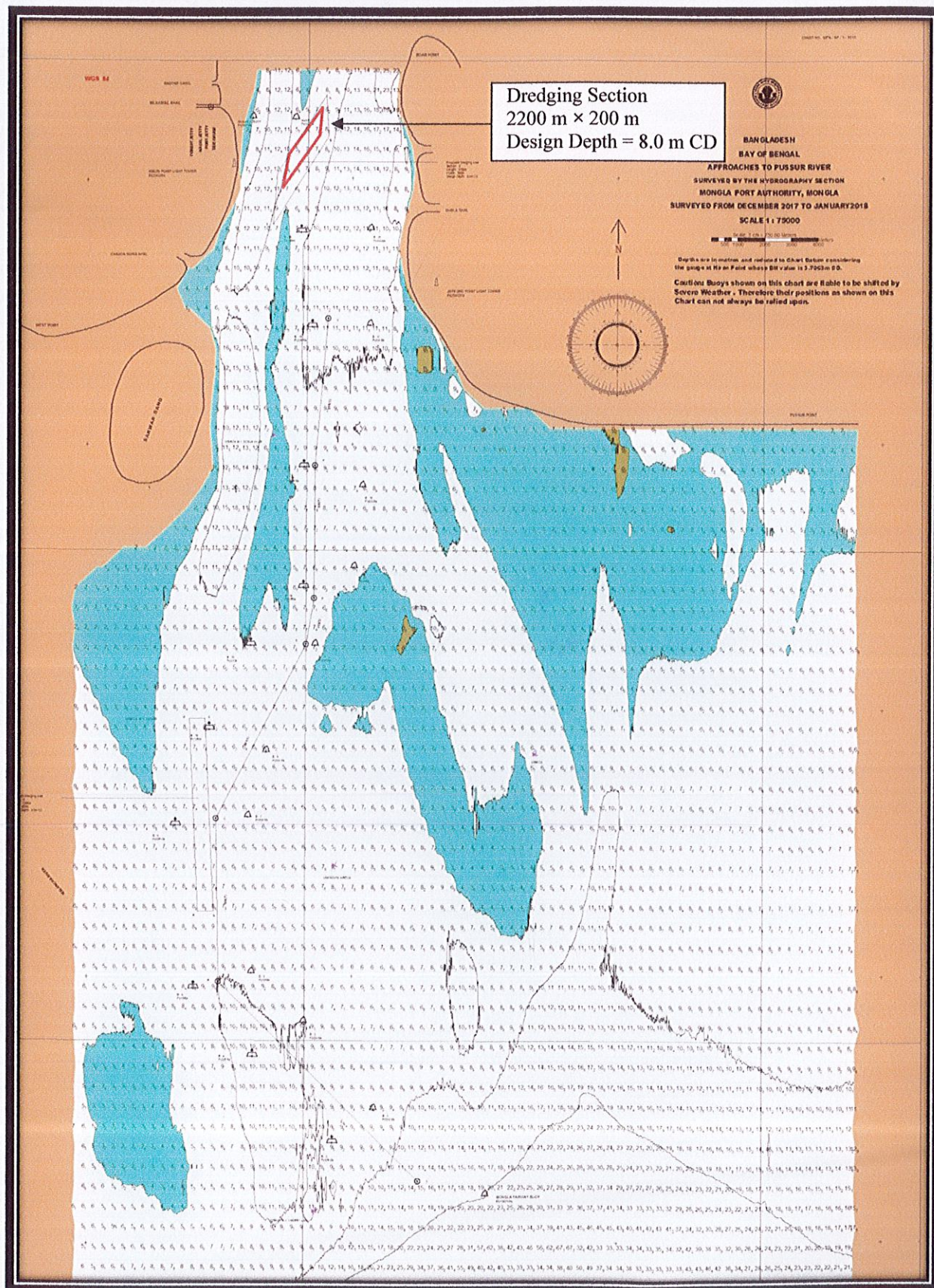

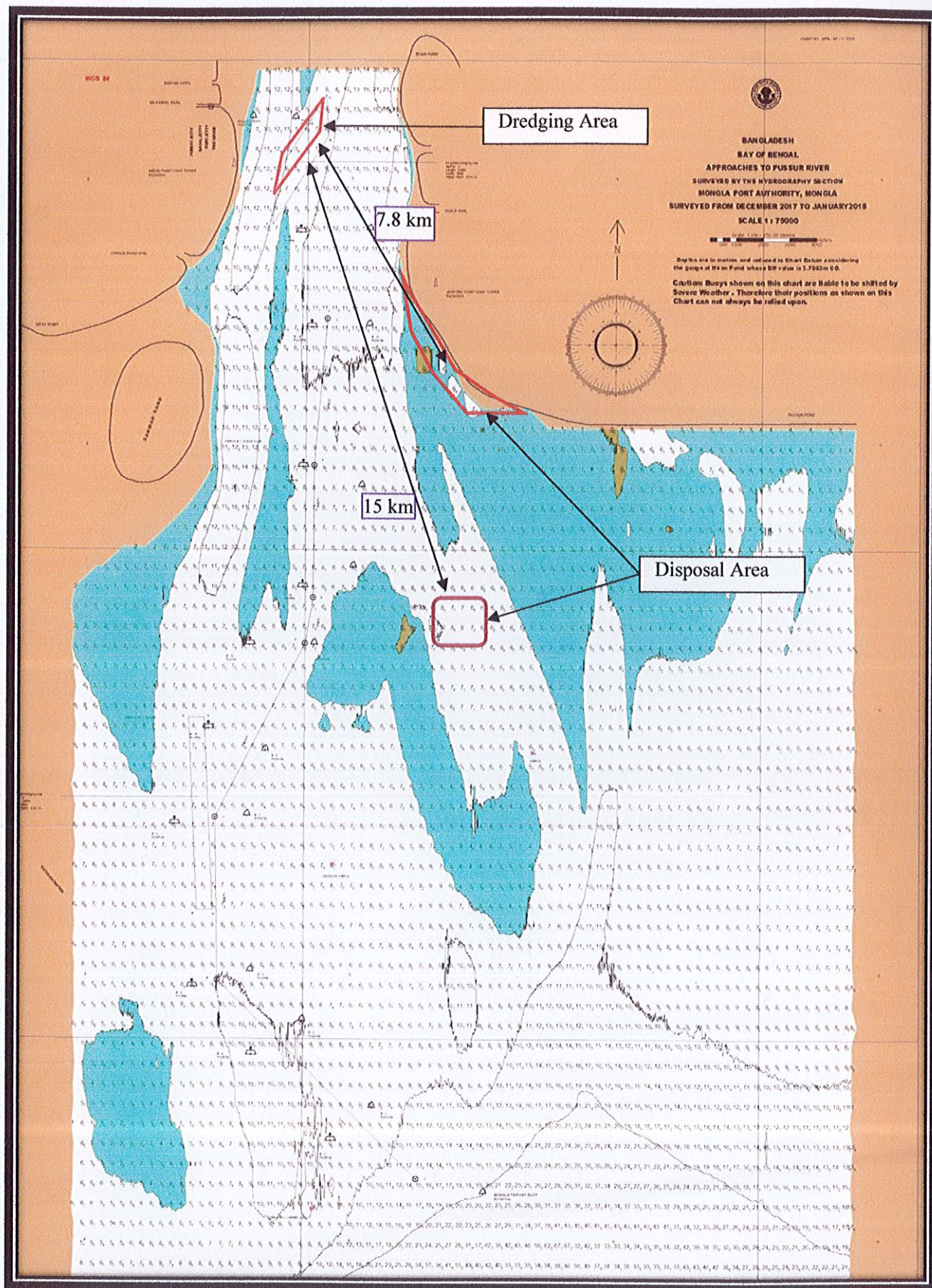
